**OFFICIAL RULES**

Eligibility.** Open only to U.S. residents of the fifty states and the District of Columbia, excluding Rhode Island, who, as of date of entry, are between the ages of 18 years and 36 years, have access to the Internet, and have not purchased Internet service in order to participate in this Sweepstakes.
